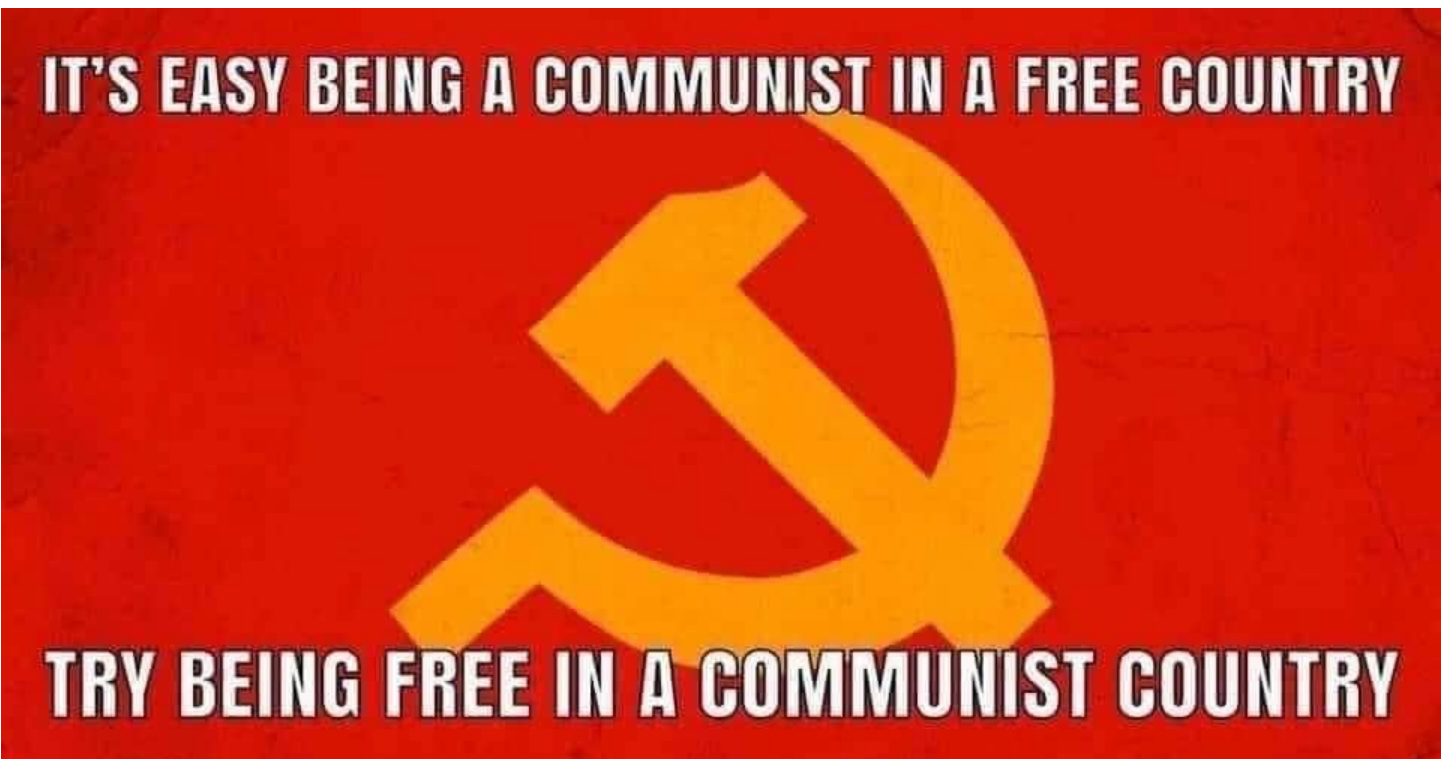

Putnam Co. Commission Chambers – Palatka, Florida

On the evening of November 10, 2020 we would journey to the City of Palatka, Florida located in Putnam County, to voice our support to the recommendation of the County Commissioners special appointed citizen committee whose charge was to present to the Commissioners a course of action on what to do in the location process of the Confederate soldier's Cenotaph from its place of honor on the Courthouse grounds.

At their final meeting, the Committee would propose to the County Commission to leave the Cenotaph in place. However the moderator, a paid County employee directed them that they should have at least two more recommendations... (1) Melrose Park was suggested; they refuse; (2) Move the Cenotaph to Palatka Veterans State Park - no such entity exists...this is a causeway stretch of land below a bridge located in the flood plain adjacent to the St. Johns River that runs north; and (3) Let it remain on the Courthouse grounds.

It is important to mention here that this committee was never provided with minutes of this final meeting that they have continuously asked for.

And not to forget, we had come to dispute the false Jim Crow narrative being presented. And that this Cenotaph is clearly representative of the integrated armed forces of the Confederate States of America, unlike the segregated Union forces. And, not to forget that every member of the Supreme Court with the exception of one former Southern plantation owner voted against Jim Crow.

I would also tell those present that the two black women and the three white folk guilt women who tried to convince those present in believing the lie about how black folks who gathered daily around Confederate Cenotaphs on courthouse grounds just like Palatka's all across the South taking pictures, eating, drinking, smoking, or just plain confabulating with each other in the most festive and joyous terms; are so mentally distressed by its presence, and affirms in their minds that there will be no justice served by the functionalities in the courthouse building.

I suppose that Judge Calvin Hill, the only Democrat that I would vote for in this election and all the other black Judges who adjudicate in these like circumstances will affirm this lie. I doubt it!

The Commission Chair, after two motions to remove the Cenotaph to the “so-called Veterans Park” failed to get a second, said that he was tired of this affair and vowed to bring it to closure on this very night.

The renowned, honorable and courageous Attorney David McCallister would rise from his seat and, with his fist pumping, would exclaim rightfully to the Commissioners that they had just “sold out” the people of Putnam County. The Commission Chair would sadly retort that if this entity had not raised the two hundred thousand dollars in 90 days, the Cenotaph would not be bothered again.

My recommendation in an upcoming report to both Save Southern Heritage and the Southern Legal Resource Center's Board of Directors is that we began exploring a criminal and civil class action procedure against these municipalities to include Putnam County. And that we began major fundraising campaigns to those ends.

I would be willing to begin a fundraising March from Selma, Alabama to Austin, Texas as a part to this fundraising campaign.

It has become increasingly clear that far too many of these Southern elected officials led by their Yankee conspirators have sold and are willing to sell out the South, and the moral righteousness that led to the Honorable Stand that the people of the South, our ancestors red, yellow, brown, black, white, freed and indentured made its Stand against tyranny and the Constitutional Rule of Law, and the illegal invasion of the Union Army; a force armed with total warfare orders against defenseless old men women and children as they brought the theater of war to their front door. 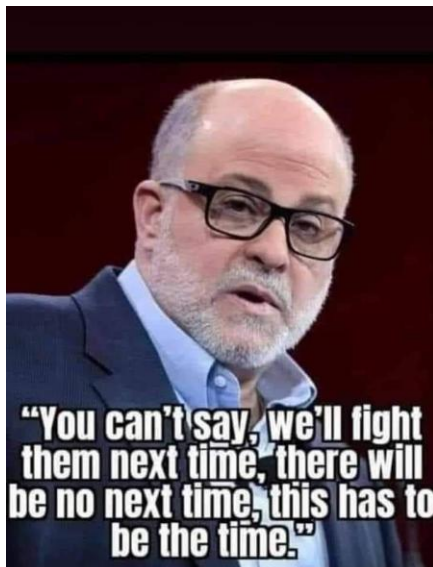

Chairman's Report

The last time I had the honor to address this group was on October 27, 2020, just Days before the Presidential election. In the intervening 3 month period, a well coordinated and successful insurrection has been completed. On October 27th, many in this room were aware that the Communists were plotting to steal the election. Their plan was to steal the election by counting the vote until they got the numbers they needed. The mail in ballots were fertile ground for theft. It's why the Biden campaign did not campaign. The powers that be had already determined that Biden and Harris could not win the election. They knew that the most likely outcome would be a huge Trump victory.

The Communists could not allow Trump four more years. Democrats, now correctly called Communists, have been stealing elections in our urban centers for over 60 years that I am aware of. It is how they keep corrupt local politicians in office in spite of their failure to perform. In fact, the very concept of the popular vote, created in the urban centers, has been the result of fraudulent elections. It's why Conservatives are not elected in St. Augustine. And the sad part is, the Republican Party does nothing to expose it. Instead, they were complicit in the fraud. The only difference in 2020 is the magnitude. So great was the fraudulent count that it couldn't be concealed.

The fraudulent election of 2020 has now been imposed on America. No future election will ever express the will of the people again and the concept of Liberty is being politically terminated. Of course, the theft of the election has created a Constitutional crisis. The White House is now occupied by a criminal who belongs in a jail cell not the oval office. The 'Government Buildings' are cordoned off with chain-link fences and concertina wire. Troops, of questionable loyalty to the usurpers, are being deployed in the Capital in order to display the appearance of power and are being disgraced by forcing them to sleep out in the cold and to do without adequate toilet facilities. Washington is no longer the people's seat of government. It is a captured city and is occupied with those whose allegiance is to global interests, including the Communist Party of China.

With Trump still in the White House, a vibrant Tea Party meeting was held here on January 12th. The Tea Party meeting was electrified with a determination to expose the False Flag hijacking of the otherwise peaceful protests on January 6th.

Tonight, we conduct this meeting with Biden, more to the point, Harris occupying the White House. There are members here that have been part of this Grassroots Movement since 2009. They have witnessed dark days before, the reelection of Obama in 2012 for example. This Tea Party stood down after the 2012 election until January of 2013 as it did this year after the 2020 election. When Obama came after the Guns following the Connecticut shootings, our activists took to the streets in protest. The “Conservative Movement” continued to grow. The transition from Tea Party to Trump was culminated in 2016. The establishment coalition between the Democrat and Republican Parties was caught completely off guard. January 20, 2017 was the very moment that the insurrection by the Washington elites began. The false flag event at the Capitol on January 6, 2021 signaled the start of the annihilation of the people’s choice for President.

Donald J. Trump was elected President on November 3, 2020. Everybody knows it, including the Communist Democrat leadership. That’s why they need to impeach him, he is the legitimate President. The Republican establishment also knows it. They cannot have Trump as President. They are, along with the Democrats, too filthy and too corrupt to endure a thorough examination of their loyalties. Many have been bought by the Chinese Communist Party.

Donald Trump spoke to the Grassroots Movement in this country. He promised to “Drain the Swamp”. It was music to the ears of the Conservative Movement. Panic to the Washington Establishment. But, speaking truth to power has consequences. Trump has been rejected by nearly everyone in Washington. Not since Joe McCarthy has anyone been so universally rejected. McCarthy exposed Communists in the Intelligence Services, the State Department, the Army and Communists in our beloved Hollywood. All true, but he was destroyed because he had no base or support. There was no Conservative Movement in his day. The Washington Establishment destroyed him with the aid of the media. He died, a broken man at the age of 48, from hepatitis brought on by excessive alcohol use. It has been suggested by some that the doctors at Walter Reed Hospital allowed him to die. They simply failed to recognize the seriousness of his illness and didn’t treat the illness. Truth Sayers are often eliminated by the political forces they oppose.

Trump, on the other hand, has emerged from the Presidency and the four year assault on his person, energized. He enjoys a national Grassroots Movement of Conservatives, some of which cheered his motorcade from the airport to his home in Florida.

Trump preferred to embrace the Republican Party for his run for the Presidency. He thought he could win them over by his good works. But, Republicans can never embrace the concept of MAGA because it goes against the “New World Order” agenda that the GOP leadership supports. And in the body of the “New World

Order” lies the corruption and sellout of America to foreign and hostile interests. The Conservative Movement seeks no overthrow of the government. The Republic, as originally formed with the current Constitution, offers more than enough remedy to our current dilemma. The trouble is that the Constitution is no longer being applied. The Tea Party’s ten year observation of Republican candidates has shown us they have little or no understanding of the Constitutional restraints on government. And when Tea Party candidates were put forth, they were viciously opposed by the Republican Party; much in the same way that the party resisted and opposed the Presidency of Donald J. Trump.

There are few public officials today who live up to the oath required by the Constitution. A breach of that oath makes them eligible for removal from office. And those who have sold out to foreign agents are treasonous and should be dealt with in an appropriate manner. Once our politicians understand that they are going to be held up to a Constitutional standard the very nature of their behavior would change.

I follow the Facebook pages of our new and activated Patriots in Northeast Florida. I see the newer activists proceeding with the same tactics that the Tea Party attempted in its early days. They encourage people to contact their elected representatives in the belief that the public officials will follow the dictates of Conservative people. They believe that going to public meetings and speaking for three minutes is going to influence their local government. They believe that the election in 2022 will stop the march to Socialism by winning the House. The idea of forming a new third-party is talked about. And, perhaps, the most delusionary idea is the infiltration and, thereby, the transformation of the Republican Party into a “Constitutional Conservative Party”. This is an idea that never existed in the Republican Party, all the way back to Lincoln. Not Goldwater, not Reagan nor Trump gained a permanent change in the party. Sixty years of failure is the historic lesson.

I say to the new Patriots, “You are following in our footsteps. We did the things you are proposing. We failed with those tactics. Karl Rove and his Bush family types destroyed the Tea Parties with the help of the media”.

This Tea Party still exists today because we rejected Republican control, preferring a Grassroots status without the confines of party loyalty. From early 2012 on, we focused on the people. In 2012, Tea Party rallies began to fail. The SATP’s 2012 Tax Day rally was no exception. So we took the rally to the people.

We were, and are, fortunate to have an ever changing national audience to engage in the Historic District of St. Augustine. The audience changes daily. On our website, there is testimony to the thousands and thousands of pictures that were placed on the Internet. And that does not include the photos the public took of us; pictures of the public interacting with us, pictures taken from cars and the Trolley Trains. How many pictures are impossible to say, but it was a huge number. All found their way into social media and emails.

And who fought our efforts to constitutionally educate the public? None other than, the local Republican Party, with the support of Lenny Curry as the head of the Republican Party of Florida. We are not claiming we woke the country up, but we did our part and in the end Tea Party rallies resurfaced as Trump rallies.

The first Trump rallies were organized by Tea Party leadership. Going to a Trump rally was like going to a Tea Party rally of old; the same music, the same format and the same enthusiasm. The only difference is the Conservative Movement now had and has an effective leader in the form of Donald J. Trump.

To the new Patriots, I point out again that an insurrection has occurred. The election process is in the hands of America's enemies. The current Politicians are relieved to know that they do not have to be concerned with the people's input anymore.

The Communists or the Constitution will prevail. Only one, will stand as they are mutually exclusive. A house divided against itself cannot stand. Our nation is as divided as it was when Lincoln delivered those words in 1858. The struggle will be forth coming.

The house divided expression, a quote from the Bible, also applies to the various Conservative groups in Northeast Florida. There seems to be a lot of duplication of efforts.

And while there does not seem to be a lot of infighting, there is no focus on the real issues.

Our political free speech is meaningless without our votes standing for something. The Communist insurrection has been allowed to reach this stage without opposition. The best opportunity to overturn the insurrection was before Trump left office. He had the power to declare martial law. Trump had the duty to do it. But he didn't. The fraudulent election was allowed to stand.

This Tea Party kept the Grassroots Conservative Movement alive in Northeast Florida during the dark days of the Obama administration. Though other groups joined us from time to time, no other group focused on engaging the people, the only place that can make a difference. For eight years, we enjoyed the affection and respect of the American people. Hell, sometimes it felt like being a rock star. It was a weekly event.

Dave was on St. George Street on this Martin Luther King Day, conducting a poll about public support for Trump. Over 92% of the people showed support for Trump. The enthusiasm for Conservatives on St. George Street has not diminished. The Historic District is a great asset for Patriots in Northeast Florida. It provides the opportunity to be seen by a minimum of 8000 people each time we engage the public.

Now I know that some of the new Patriots have been on St. George Street with less than stellar results. On the Fourth of July, more than 100 people walked up St. George Street. I was unable to join you because of my failing hip. The Town Criers were never able to put more than 20 people at a time on the street. But that spectacular group of 100 went up St. George Street at 9 o'clock in the morning. The streets are empty at that time of day. Without people it is meaningless to be on the street. To make things worse, the City was in shutdown as the City Commissioners canceled Independence Day. Try your march in the Historic District when people are there. It's a whole different world.

United, we Patriots can make a big difference. We need each other. Pushback in this fashion may be the only alternative for the time being. But it will have a national impact. This is not an untested theory. The Town Criers have made over 200 marches in the Historic District of St, Augustine, Florida. Learn from our experience.

We made progress under Obama tyranny, so perhaps we can make progress under the Biden-Harris tyranny. All I know is, we must push back or they win. Together we can do this. I'm calling for Patriots in the area to unite under one roof. That roof could be a permanent "Safe House". A safe place maintained as a refuge for hanging out, a place to inspire, encourage, support each other and plan activities to dislodge the usurpers of our American Heritage. Conservatives from all groups would be welcome. It is time to unite our efforts.

Our founders understood the need for unity. Ben Franklin has been credited with saying in 1776, "We must all hang together, or ... We shall all hang separately". Failure to unite will cause us to be picked off, one by one. The 2nd American Revolution has begun to restore the Constitution. Will you join the fight?
