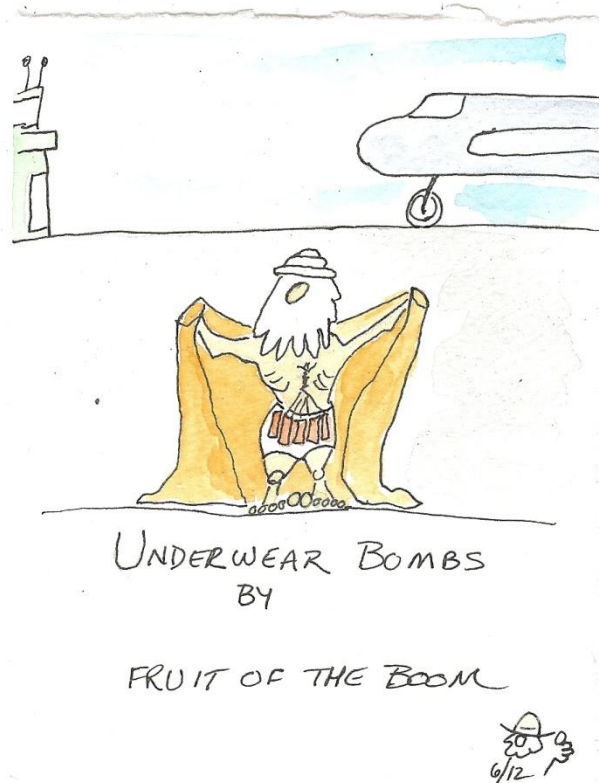

The clock ticks, and our grandchildren grow, and American history impatiently awaits our decision, one way....or the other.

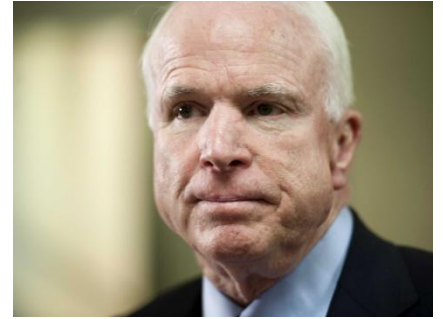

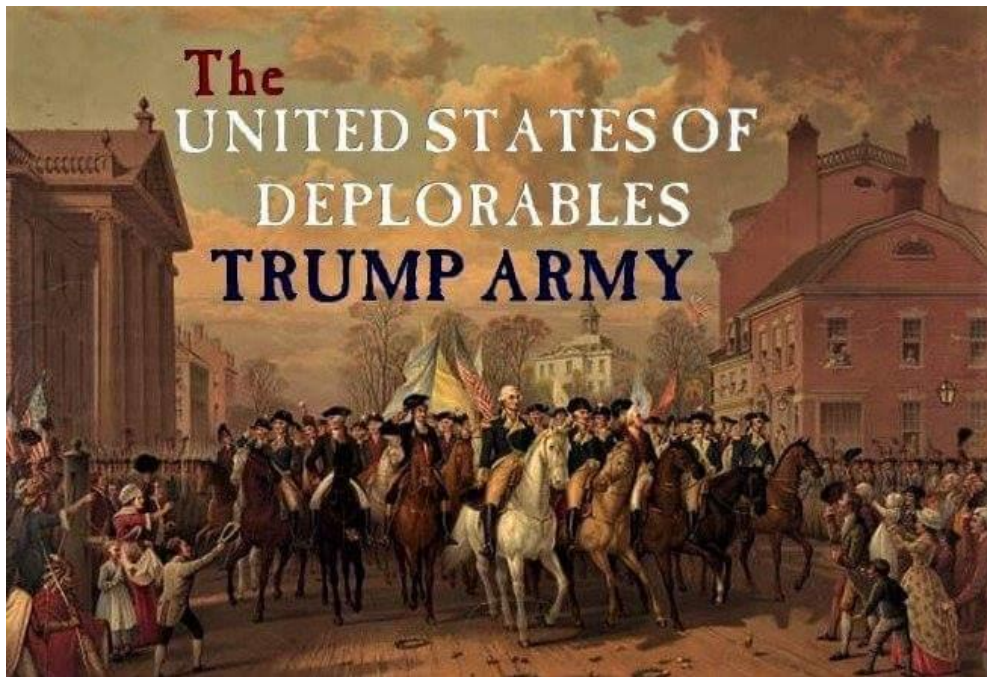
The other choice is to lead the populist movement that elected you President.

Pastor Attacks Vets

Confederate Mania is Attacking History in America's Oldest City

Confederate soldiers are considered U.S. veterans under federal law, and they would be entitled to the same benefits as Union soldiers if they were still alive. This is because of an act of Congress, passed in 1929, Public Law 810 and various other federal laws.

There are two monuments associated with the Confederate era located in the historic district of St. Augustine, Florida. In 1872, the citizens of St. Augustine erected a monument in remembrance of soldiers who never returned home. Their relatives and friends wanted these veterans to be remembered. They

served with honor and the people wanted their loss to be mourned.

The second monument is the Loring Memorial. Maj. Gen. Loring's remains are buried under the memorial. This veteran's memorial displays the flag under which he served. This is a right that all veterans are entitled too.

Cultural Marxist Agenda Exposed

About 100 people showed up at St. Paul's AME Church on August 21st to hear the church's pastor, Rev. Ron Rawls attack on the City's Veteran Memorials. He demanded that city officials act quickly to remove two Confederate monuments that occupy space in the historic district.

Race Baiting Saul Alinsky Style in the Oldest City

A black Pastor, who happens to live in Gainesville, started a flurry with anti slavery ranting in St Augustine. This got the knee jerking politicians scrambling to kiss the backside of this race rioting instigator. The so-called Pastor of St.

Paul's AME Church in St Augustine demanded the removal of the two monuments by August 28th, or else.

The City immediately adjusted their agenda so that the five City Commissioners could weigh the merits of this absurd request.

There were rumors going around that there was going to be a rumble at the Plaza de la Constitucion located in the center of historic of St. Augustine, Florida. Everyone was alarmed because of the violence that just happened in Charlottesville Va.

The local Tea Party and others had received reports of two busloads of Black Lives Matter and Antifa were coming to the City. In addition the local Communist group, the Indivisible St Johns, joining in had everyone on edge. Though, not a single Indivisible was on the Plaza to resist. Added to that was the fear that the masked Antifa was going to deface the Confederate Memorials in the Plaza. Nothing rattles the patriots more than disrespecting our dead Veterans in the name of "civil rights".



Disinformation Back Fires

It now appears that the report of busing in outside agitators was a scare tactic. It was designed to keep opposition to the monument removal to a minimum. The BLM and Antifa rumors of confrontation scared no one. In fact, it had the opposite effect. Between 100 and a 150 people held a vigil and stood guard in the Plaza while the Commissioner's meeting was in session.

The St Augustine Record's coverage of the Plaza demonstration was a picture with three people shown and the following statement, "About 20 people, some carrying American flags, and many wearing military garb, took up position near the obelisk which was built to honor those from St. Augustine who died fighting for the Confederacy."

The reality of the situation is that many liberty minded organizations had representation at the Plaza de la Constitution. This is an excellent example of "Fake News".

"This is what grassroots demonstrations looks like," a veteran of the early days of the Tea Party said. "No one organized this diverse collection of individuals. If there was a stimulus to the gathering, it was the rumors caused by disinformation." The demonstrators displayed numerous full sized flags. The American flag, Confederate flags of varying types, Blue Lives Matter flag in support of our police, the Florida State flag, the Christian flag, 3 Percent United Patriots (3 %ers) or 3UP flag and the Tea Party's Gadsden flag created a hue of truly patriotic color. The Tea Party carried a sign that said, "The Goal of Socialism is Communism". It was a big hit with the other patriots. The Tea Party was the only group with signage.

One of the more predominant groups was the 3 %ers. About 20 individuals dressed in military garb were there to provide security. At the time there were rumors that there were buses on the far side of City Hall unloading outside agitators.

Interviews with the police revealed that they had no knowledge of such a situation that came from official sources. They were hearing the rumors only from the public. The local police department was there to keep law and order. They even had cameras in the trees to record any hostile acts.



Meanwhile, at the City Commission meeting, about 75 people were in the process of addressing the Commissioners during public comment. Reports from Tea Party members inside described a tense atmosphere.

Initially the speakers were predominantly Ron Rawls' people. Procedure permitted citizens of St. Augustine to speak first. Reports indicate that about half were for and half were against removal. At one point, Rev. Ron Rawls attempted to exceed his three minutes and the Mayor cut him off.

A Tea Party person, who wishes to remain anonymous, was in the overflow room and felt intimidated. The person did not want to walk the streets after sunset. So this person left before speaking. The person did not realize that security was available

As the evening went on, speakers advised the commission about the consequences of removal. For example state statute protects public monuments. Other speakers pointed out that these are Veteran memorials. Federal law recognizes Confederate soldiers as American soldiers. At about 9 o'clock, one of our Tea Party members, Judy Stevens, said the following about State's Rights:

"I hope that the City Commission is not going to be swayed by a small minority of hate filled people who want everything about our history destroyed. This Commission does not have the right to speak for the people of St. Augustine until they put this issue to a Vote. When a White Country elected a Black Man to the highest office in this Country, I would have thought that would have put the subject of racism to bed. I can't believe we are having this discussion about removing historical statues of people that believed in what they were doing and served the people well. This is our history! The Civil War was not just about slavery as the slaves were being gradually freed anyway, it was much more about the oppression of the Northern States against the Southern States over taxation and the Southern States had every right under State's Rights to oppose them. Our southern Generals and army fought valiantly and their memory should be preserved as well as the idea that if the States are oppressed, they have the right to secede."

Another Tea Party member, Doug Russo, growing weary of the insults to his southern tradition, verbally attacked a black icon, which created a heated reaction from several blacks. This resulted in them being removed from the chamber. Mr. Russo, concerned about walking alone in the dark streets, after the meeting concluded, obtained security from three 3 %ers.

An initial survey of the public's opinion to keep the statutes was 10 to 1 against the removal. The sample of the survey exceeded 10,000.

The City residents had been in a tizzy of speculation. The late night meeting came and went without a stone being tossed, a punch being thrown, or a shot being fired. According to the Tea Party's Town Criers, there was much ado about nothing. Fortunately, the presence of the 3 %ers and various well equipped patriots from around the State showed up to put down any possible insurrection. The Town Criers, of the St. Augustine Tea Party, wish to thank the 3 %ers and other patriot groups from around Florida for coming in force to keep the Communists from destroying the St. Augustine monuments. If the politicians cave once again to the cry of the left, we now know that we will have faithful patriots to resist with us.

The days of compromise are over.

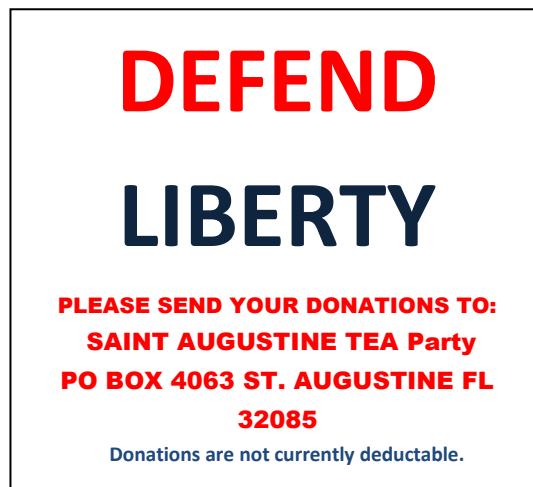
