## Regionalization Neutralizing the People's Voice UN Agenda 2030 Dominates Local Governments

There is a trend in America that is squeezing the people out of the decision process in local governments. Elected officials appear all too willing to delegate their authority to unelected bureaucrats. City and County Commissioners hire municipal managers and municipal attorneys to run the every aspect of governance. The managers and attorneys are the products of the "Schools of Municipal Administration". The institutions of higher learning in America, with a few exceptions, are bastions of the radical, Marxist ideologies. Complicating the process, our elected officials participate in a process of regionalization. This is the world of UN agenda 2030 goals. The whole process becomes un-necessarily complicated and the municipal attorneys reign supreme. City and County attorneys pretend to be practicing law when in fact they are administrating bureaucratic rules designed to implement the "New World Order". This is the realm of intergovernmental boards and committees.

Any citizen who has spent time presenting his views before a City or County Commissioner's Board meeting, in a three minute public comments session, understands how irrelevant he or she is in the decision process.

The SATP members have a concern about the cultural war that is raging in American. "Revisionary history is completely unacceptable in a city that reports to be the 'Oldest City in America', and is a historic time capsule," SATP Chairman, Lance Thate, said in a recent interview. Community organizer, Ron Rawls, pictured upper left, presenting the communist salute, has since the Charlottesville, Virginia riots been demonstrating in the streets of St Augustine for the removal of the "Veteran Memorials" in the historic district. The Veteran Memorials date back to the Confederate period.



The memorials do not glorify the Confederacy, but honor the veterans who served. Rawls' protesters are largely imported white communists from front organizations like the Occupiers, Black Lives Matter, New Black Panther Party and elements of Antifa. So far, the citizens of St. Augustine area have been able to save the monuments from destruction.

But, Rawls has support within city government. City manager John Regan, pictured right, has demonstrated close support for Rawls' effort to have the monuments destroyed. Boasting last year, Regan claimed he could have the monument down in eight hours, without public interference, by doing it in secret at night. Tea Party member and former City Commission candidate, Jill Pacetti, stalled the rush to destroy the Monuments by presenting a petition with 11,000 plus signatures demanding that the historic monuments be saved.

## City Commissioner Nancy Sikes Kline Attends Tea Party Meeting

On November 27, 2018, Nancy Sikes Kline, newly reelected, City of St. Augustine Commissioner addressed the SATP's open meeting. The Commissioner would have preferred to talk about other issues facing the city. However, the SATP members were fixed on discussing the controversial contextualization issue. The Vice Mayor, Todd Neville and the City Manager were Ron Rawls', chief supporters in destroying the monuments. When they failed, the City Manager suggested contextualization and the City Commissioners concurred by following his recommendation. Ironically, he was also picked to create a contextual advisory committee.

Tea Party members found it alarming that someone so willing to destroy the monuments would have been placed in a position to discredit them. By appointing J Michael Butler, a Flagler College history professor, pictured above on the right presenting the communist salute, the slanderous die was cast. Soldiers dead for 153+ years will now be singled out as white supremacists by the communists in the 21<sup>st</sup> century.

David McCallister, a spokesman for Saving Southern Heritage, Florida, traveled from Tampa to attend the Tea Party meeting. McCallister suggested that the reason contextualization is applied to monuments is that it discredits the monument so that those who support preservation no longer react as enthusiastically. "Ultimately, the monument or statue is removed or destroyed," McCallister said.

The Commissioner defended her vote to go forward with the contextualization by suggesting that the process was open and transparent. She asked if anyone had attended any of the contextualization meetings. To her surprise, she found that many had. To a person they expressed frustration with the treatment they received.

Sikes Kline stressed that only the finest, brightest and most qualified from academia, was chosen. The political activists in the audience were not impressed with the blatant display of the elitist mindset. It was pointed out that one of the elitist appointees, Michael Butler, had been seen instructing "Black Lives Matter" protesters in

front of “The Bunnery”, a local restaurant on St. George Street, on October 31, 2017. The issue at hand was an employee who, for Halloween, came to work as “Aunt Jemima” and was in blackface. This offended a white Flagler College student. An all day unlawful picketing event occurred as the police looked on. The police answer directly to the City Manager. The employee went home in tears and the business has since been sold, but Butler’s partner in crime, Ron Rawls, makes a point of picketing the business routinely. It has become a protest shrine for the communists in St. Augustine. Since the initial protests on Halloween, numerous picketing violations have been observed by the City Manager’s police force in front of the Bunnery. In the name of the First Amendment near rioting conditions are permitted. The Commissioner did not address these issues.

Nancy Sikes Kline’s relatives have a long history in St. Augustine. The Commissioner has a family member inscribed on the Confederate Veteran Memorial. She often displays southern charm. The Commissioner had expressed an interest, when she was present at the Tea Party’s candidate forum on October 23, 2018, of hearing dissenting views. She said, “I had no idea there was so much opposition to contextualization.”

This encouraged many within the Tea Party to hope that Commissioner Sikes Kline could be encouraged to make a motion to reconsider contextualization discussion. From their perspective, there had been no outcry from the public for contextualization and the Rawls forces want removal, not contextualization. No one seems to be interested in rewriting history except the City Manager, those on the City Commission who supports him and the Contextualization Committee itself, all City Manager appointees.

In the realm of City government, with communist salutes surrounding Nancy Sikes Kline and her fellow Commissioners, the agenda is revisionist history regardless as to what they might say. Nancy Sikes Kline was asked on numerous occasions to reconsider the discussion on contextualization. She was adamantly opposed.

Perhaps, she opposes reconsideration because it is already a done deal. Jill Pacetti suggested that she had reliable sources that confirmed that the plaques were already ordered and paid for. The Commissioner did not deny the claim. Instead, Nancy Sikes Kline volunteered that payment does not require Commissioner approval if the amount is less than \$25,000.

After the meeting, the Tea Party Chairman, Lance Thate, suggested to the Commissioner that, "It's time to do the right thing Nancy. After all, the monuments do not belong to the City they belonged to the community at large." The fact that the monuments belong to the community at large is perhaps the only point of agreement between Nancy Sikes Kline and the Tea Party.

The City of St. Augustine represents, according to Commissioner Sikes Klein, only 6% of the greater metropolitan area. She went on to say that the County no longer pays much attention to them. But this small minority will rewrite history for not only the surrounding community, but for the national and international visitors to the city as well. Revisionary history is a major agenda item of the Communist Party USA.

One could question whether City and County Commissioners and the Administrators are in fact communists? They are following the communist agenda. Giving them the benefit of the doubt, we will conclude that they are not members of the Communist Party. In the former Soviet Union, there was a term for those who were not party members, but further, the party's goals. They were called "Fellow Travelers".

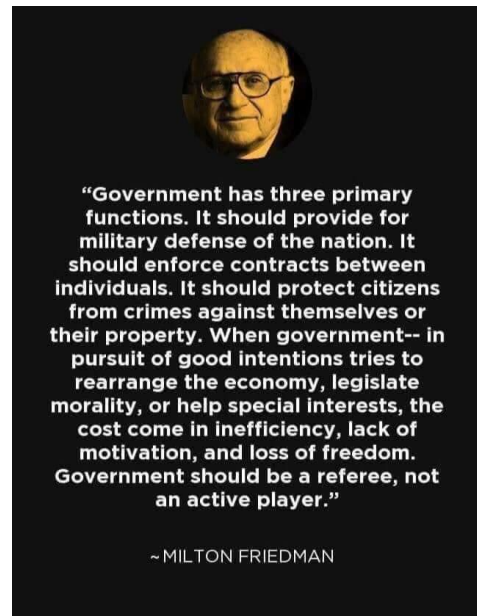
